

Coral Gables price cuts and true days on market

HEADLINE OPTIONS

1. 39.6% of Coral Gables houses for sale have cut their asking price, 34.7% of condos
2. Coral Gables sellers blink faster than the rest of Miami-Dade County as 43.2% of houses pass 90 days on the market

CORAL GABLES, Fla., September 5, 2026 - 39.6% of the 139 single-family homes listed for sale in Coral Gables have reduced their asking price at least once, by a median 6.7% (about \$200K), according to a daily analysis of BeachesMLS listing data by PBP Real Estate. Among the city's 118 condominium listings, 34.7% have cut, by a median 4.4%.

NUT GRAF

The figures point to a market where roughly one in three homes finds a buyer only after a price decision: of the 42 Coral Gables houses now under contract, 45.2% reduced before going under contract, with a median cut of 7.2% and a median 48 days to contract. Across Miami-Dade County the price-cut share is 37.7% for houses and 37.4% for condominiums, so Coral Gables houses are cutting 1.9 points more often than the county. Counting every relisting, the median Coral Gables house for sale has been on the market 75 days, against 75 on its current listing; 0.0% of active houses have been withdrawn and relisted at least once.

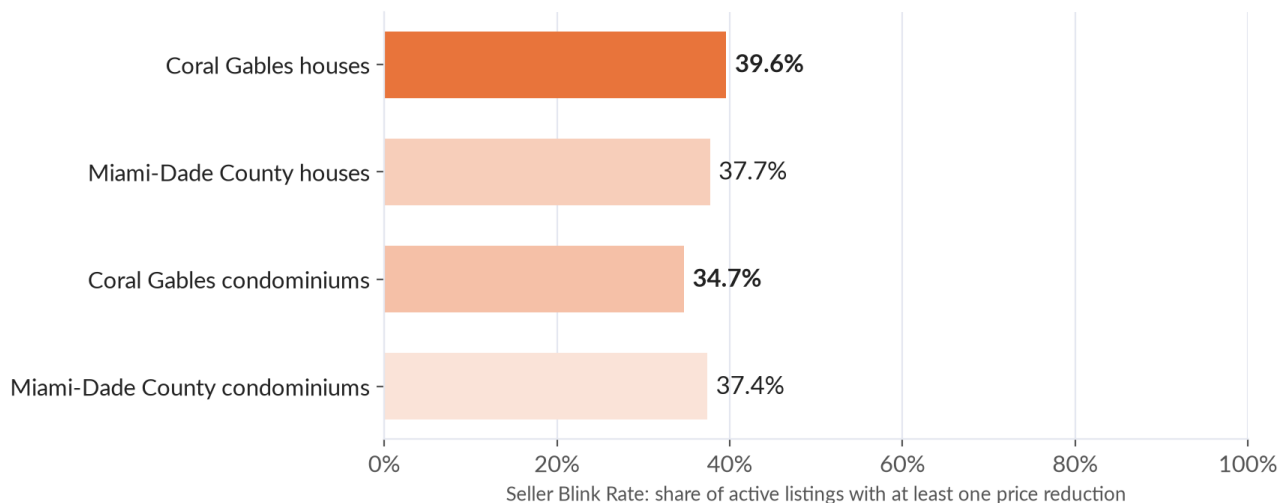

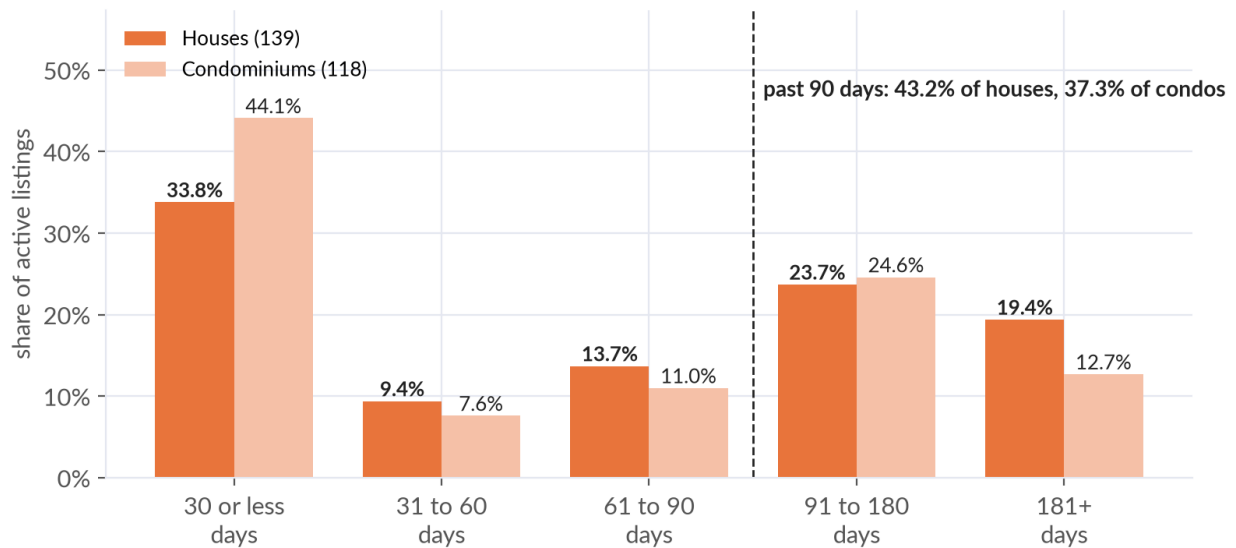
Coral Gables houses are cutting 1.9 points more often than Miami-Dade County

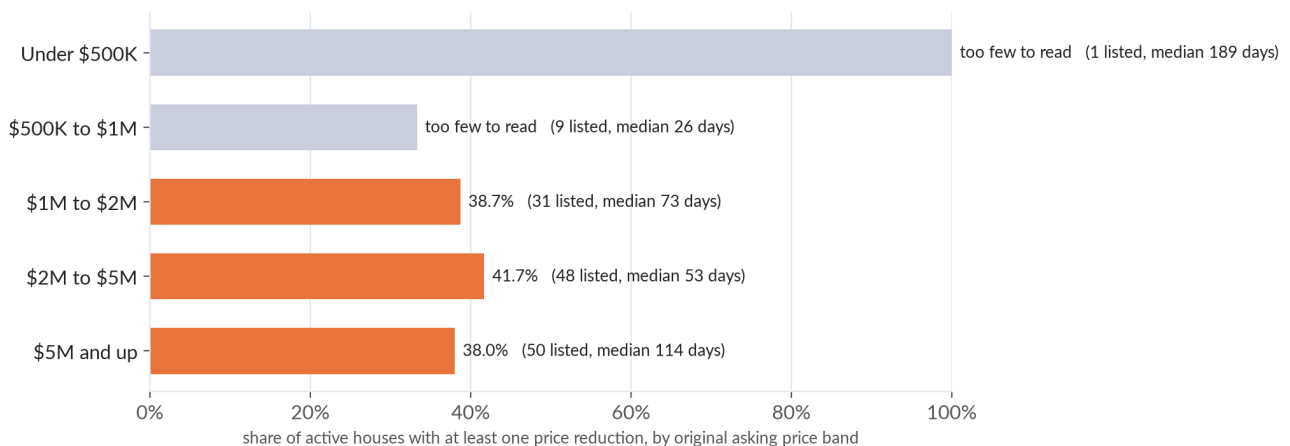
43.2% of Coral Gables houses for sale have waited more than 90 days, counting every relisting

METHODOLOGY

Method: counts and medians over active and under-contract residential listings in Coral Gables and Miami-Dade County permitted for internet display in PBP Real Estate's BeachesMLS data feed, snapshotted daily at about 5:00 AM Eastern; this kit reflects listings as of September 5, 2026. A price cut means the current asking price is below the original list price. Cumulative days on market counts every relisting; days on market as shown on portals resets on relist. Houses are single-family residences; condominiums

exclude townhouses and villas; the two are never combined. Under contract includes Pending and Active Under Contract. Price bands with fewer than 30 listings are marked; fewer than 10 are not read. Sample sizes: 139 houses, 118 condominiums, 42 houses under contract. No estimate or model is applied; every figure is a count or a median of MLS fields.
